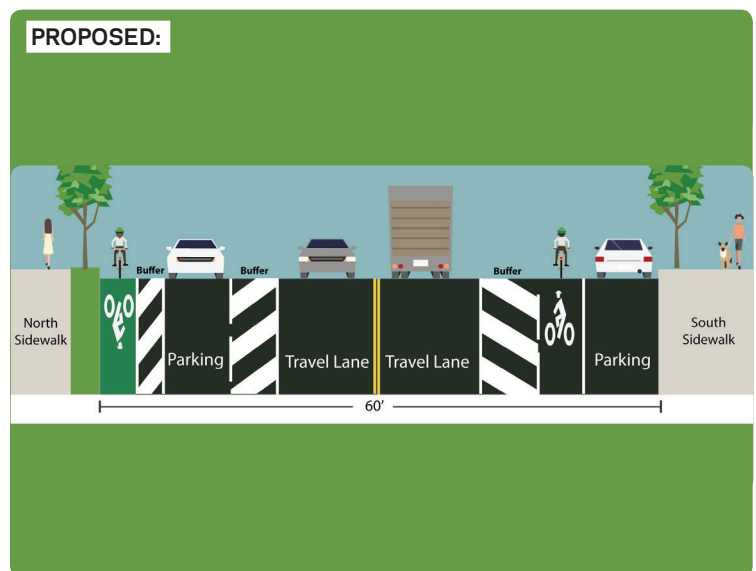
Improve Pedestrian Safety

On Monday, August 20th, NYC DOT will begin to mill Dyckman Street from Broadway to Nagle Ave in preparation for resurfacing, which is scheduled to occur at the end of August (weather permitting).

Once completed, NYC DOT will implement safety improvements including:

- Install parking-protected bicycle lane on the north side of the street
- Add curbside buffered parking lane on the south side of Dyckman Street
- Painted pedestrian space

Thank you for your correspondence regarding the protected bike lanes on Dyckman Street. The New York City Department of Transportation (NYC DOT) shares your concerns about traffic safety and mobility for all road users. Please excuse the delay of this reply.

As you noticed, the street was repaved last year removing the previous street design and new markings are being installed now. The new design differs from the previous street configuration by consolidating eastbound and westbound bike lanes on the north side of Dyckman Street. There will no longer be a bike lane on the south side of Dyckman Street and vehicles will be permitted to park at that curb. The new design provides more road space between parked vehicles as well as a flush center median which will allow emergency vehicles more room to pass slower traffic. New left turn lanes will reduce traffic delays.

The earlier iteration of the protected bike lane on Dyckman substantially reduced the number of injuries and crashes and we expect the new design to continue to offer these safety benefits while offering additional space and more parking.

Thank you for addressing your matter with NYC DOT.
