#### I. OVERVIEW

On October 03, 2019, panel 9B-2019 of the Civilian Complaint Review Board met and reviewed the above-referenced case. The details of the complaint, the allegations and the panel's findings are summarized below.

The statute of limitations applicable to this case expires on January 11, 2020.

## II. SUMMARY OF FACTS

On July 11, 2018, at approximately 9:30 p.m., Mr. Williams was pulled over in his white four-door Jaguar XF at the intersection of 154th Street and Shore Avenue in Queens, by Sergeant Justin Ellis and Police Officer Gregory Gromling, both of the 103rd Precinct (Allegation A: Abuse of authority - Vehicle stop). During the stop, Mr. Williams informed Sgt. Ellis that he was a peace officer with the NYC Department of Hygiene and Mental Health (DoHMH); after which, Sgt. Ellis asked Mr. Williams if he had a firearm in the vehicle (Allegation B: Abuse of authority - Question). Minutes after being stopped and presenting his DoHMH identification card, Mr. Williams was allowed to leave without being issued a summons. On July 12, 2018, at approximately 11:30 p.m., Mr. Williams was pulled over once again in his same vehicle at the intersection of Sutphin Boulevard and Arlington Terrace in Queens, by Police Officer Gregory Gromling and Police Officer Michael Boudouris, also of the 103rd Precinct (Allegations C and D: Abuse of authority - Vehicle stop). Shortly after, Sgt. Ellis and Police Officer Daniel Ward arrived at the location as back up. During the stop, Sgt. Ellis allegedly asked Mr. Williams about

a gun charge that was on his arrest history (Allegation E: Abuse of authority - Question). Sgt. Ellis ultimately searched Mr. Williams' vehicle, after allegedly telling him that he would be arrested if he did not exit the vehicle (Allegation F: Abuse of Authority - Threat of Arrest) (Allegation G: Abuse of Authority - Vehicle search). After the search of the vehicle, Mr. Williams was once again released without being issued a summons. The investigation determined that Sgt. Ellis and PO Gromling failed to prepare memo book entries on July 11, 2018, and Sgt. Ellis, PO Gromling, PO Boudouris, and PO Ward failed to prepare memo book entires on July 12, 2018 (Allegations H, I, J, K, L, and M: Other - other misconduct).

#### III. ALLEGATION(S)

- A) Abuse of Authority: On July 11, 2018, at 154th Street and Shore Avenue in Queens, Sergeant Justin Ellis stopped the vehicle in which Nicholas Williams was an occupant.
- B) Abuse of Authority: On July 11, 2018, at 154th Street and Shore Avenue in Queens, Sergeant Justin Ellis questioned Nicholas Williams.
- C) Abuse of Authority: On July 12, 2018, at Sutphin Boulevard and Arlington Terrace in Queens, Police Officer Michael Boudouris stopped the vehicle in which Nicholas Williams was an occupant.
- D) Abuse of Authority: On July 12, 2018, at Sutphin Boulevard and Arlington Terrace in Queens, Police Officer Gregory Gromling stopped the vehicle in which Nicholas Williams was an occupant.
- E) Abuse of Authority: On July 12, 2018, at Sutphin Boulevard and Arlington Terrace in Queens, Sergeant Justin Ellis questioned Nicholas Williams.
- F) Abuse of Authority: On July 12, 2018, at Sutphin Boulevard and Arlington Terrace in Queens, Sergeant Justin Ellis threatened to arrest Nicholas Williams.
- G) Abuse of Authority: On July 12, 2018, at Sutphin Boulevard and Arlington Terrace in Queens, Sergeant Justin Ellis searched the vehicle in which Nicholas Williams was an occupant.
- H) Other Misconduct: On July 11, 2018, Sergeant Justin Ellis failed to prepare a memo book entry as required by Patrol Guide Procedure 212-08.
- I) Other Misconduct: On July 11, 2018, Police Officer Gregory Gromling failed to prepare a memo book entry as required by Patrol Guide Procedure 212-08.
- J) Other Misconduct: On July 12, 2018, Sergeant Justin Ellis failed to prepare a memo book entry as required by Patrol Guide Procedure 212-08.
- K) Other Misconduct: On July 12, 2018, Police Officer Gregory Gromling failed to prepare a memo book entry as required by Patrol Guide Procedure 212-08.
- L) Other Misconduct: On July 12, 2018, Police Officer Michael Boudouris failed to prepare a memo book entry as required by Patrol Guide Procedure 212-08.
- M) Other Misconduct: On July 12, 2018, Police Officer Daniel Ward failed to prepare a memo book entry as required by Patrol Guide Procedure 212-08.

## IV. FINDING(S)

The panel substantiated allegation(s) A, G and exonerated allegation(s) B, C, D, E, F.

## V. RECOMMENDATION(S)

The board recommended command discipline B for SGT Justin Ellis.

- K) Other Misconduct: On July 12, 2018, Police Officer Gregory Gromling failed to prepare a memo book entry as required by Patrol Guide Procedure 212-08.
- L) Other Misconduct: On July 12, 2018, Police Officer Michael Boudouris failed to prepare a memo book entry as required by Patrol Guide Procedure 212-08.
- M) Other Misconduct: On July 12, 2018, Police Officer Daniel Ward failed to prepare a memo book entry as required by Patipl Guide Procedure 212-08.
