I am a reporter with The Markup. I am requesting all documents and records regarding Donald J. Trump and/or The Trump Organization's participation in the New York City Department of Transportation's Adopt-A-Highway program for a stretch of the Henry Hudson Parkway/West Side Highway.

More specifically, on this subject, I'm seeking copies of all email and written communications with other city officials, all communications with Donald J. Trump/The Trump Organization/any representative of Trump or any of his business interests, communications sent to/received from members of the public, communications with federal officials or the White House, communications with members of the media, bills and invoices, telephone and voice mail messages, and notes/agendas/transcripts from in-person or teleconference meetings.

Please limit the date range for the search to between January 1, 2013 and the date when the search for responsive documents is carried out.

You may not exclude searches of files or emails in the personal custody of your officials, such as personal email accounts. Please institute a preservation hold on information responsive to this request.□
