The Department of Consumer Affairs (DCA) has scheduled a hearing for #Error on at 42 Broadway, 5th Floor, for your petition to continue, maintain, and operate a sidewalk café at 3606 30TH AVE in the borough of Queens

1. At least fifteen (15) calendar days before the hearing, post a Public Notice of the hearing at your restaurant. You must post the notice so that it is visible to a person on the sidewalk where your proposed sidewalk café will be located.
2. At least five (5) calendar days before the hearing, publish notice of the hearing in a weekly newspaper in circulation in the community district where the proposed sidewalk café will be located.
