1. I have submitted this affidavit at the request of the New York City Taxi and Limousine Commission (TLC).
2. I am currently an officer of ROMANTIQUE Limousine
(name of company)
("this company") an entity that functions as a luxury limousine base as defined in Title 35 Rules of The City of New York City Section 6-01.
3. There are 20 "luxury limousines" that are associated with this company and are either dispatched from or conveyed information by its facility.
4. I hereby certify that more than 90% of this company's business is currently on a payment basis other than direct cash payment by the passenger. I further certify that passengers are charged on the basis of garage to garage service and a flat rate basis or per unit of time or mileage.
5. I further certify that each of the luxury limousines associated with this company have personal injury insurance coverage of no less than \$500,000. per accident where one person is injured, and \$1,000,000. per accident for all persons injured.
6. I recognize that the maintenance of the insurance coverage required above is a condition of this company's license, and agree to maintain such coverage at all times.
7. I realize that the TLC has relied upon this affidavit in recognizing this company as a luxury limousine base, and therefore not applying the additional licensing requirements for for-hire vehicles base stations set forth in local law. I agree to promptly provide financial statements and other documents when requested by TLC.
8. I further agree to notify the TLC promptly if less than 90% of this company's business within a monthly period is on a payment basis other than direct cash payment by the passenger, or any limousine associated with this company reduces its insurance coverage to less than the coverage described in paragraph 5 above..
9. I have been advised that any false statements contained herein constitutes perjury, and could be the basis for the immediate suspension and/or revocation of the black car base license.
