You are hereby charged with violating Rules 6-07(f) and 6-18(g) of the N.Y.C. Taxi and Limousine Commission's (TLC) For-Hire Vehicle Rules in that as of this date you have failed to provide proof that your livery base has the capacity to provide wheelchair-accessible service to persons with disabilities upon request, at an equivalent price and service level as non-wheelchair-accessible transportation as required by the Rules of the Commission.

You were notified on January 2, 2004 via Industry Notice (#04-01) that you were required to submit proof of compliance with Rule 6-07(f) by no later than January 30, 2004. Moreover, between July 15 and August 10, 2004, TLC inspectors visited your base, whereupon you were issued a *Notice to Correct*. This Notice afforded you an additional thirty (30) days in which to submit proof of compliance with this Rule. To date you have failed to comply with this Notice. The failure to comply with a Commission notice or directive is a violation of TLC Rule 6-18(g).

You are hereby summoned to appear for a hearing at the TLC's Consumer Relations Division, located at 40 Rector Street, 8th Floor, New York, New York 10006 at 1:40 PM on November 9, 2004.

WHEN APPEARING AT YOUR HEARING YOU HAVE THE FOLLOWING RIGHTS/OBLIGATIONS:

1. You must furnish proof that you are currently in compliance with Rule 6-07(f).
2. You may be accompanied by counsel or another authorized representative. You may also bring a witness(es) and any evidence that supports your case.
3. All fines must be paid in cash, certified check or money order on the date that the fine is imposed. Failure to pay any fine imposed will result in the suspension of your license(s) and may result in other actions to collect such fine.
4. Failure to appear for your scheduled hearing without having been granted an adjournment by the TLC will result in a hearing being held and a decision rendered in your absence, which may result in a fine and/or suspension of your license(s).
5. Any request for an adjournment must be made in person at least five (5) business days prior to and excluding the hearing date by calling (212) 676-1200.

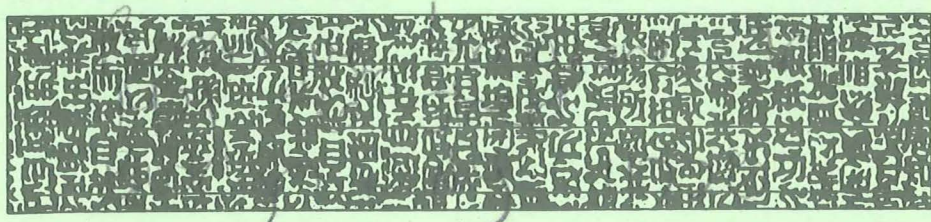
