HOW TO RESPOND TO THIS CIVIL SUMMONS

The Department of Consumer and Worker Protection (DCWP) has charged you with the violation(s) listed on this summons. You must respond to this summons. You may send an authorized representative to respond for you. Free language help will be provided, if needed. If you do not respond, you may automatically be found responsible, and you may owe larger penalties. If the Environmental Control Board or the Office of Administrative Trials and Hearings orders you to pay a civil penalty, failure to pay that penalty in a timely manner could lead to the denial of an application for a license, permit, or registration, or to the suspension, termination, or revocation of a license, permit, or registration issued to you by a City agency. This summons includes additional information about penalties.

Option 1: DENY the charge(s)

If you deny the charge(s), you can give an explanation for why you think you are not responsible to a hearing officer, who will make a decision. If you are found responsible, you will still need to pay the penalty and may face higher penalties for future charges. To deny:

- **By Phone:** Request a phone hearing at least 3 business days before the hearing date listed on the first page of this summons. To request and schedule go to nyc.gov/oathphone
- In Person: Request an in person hearing at least 5 business days before the hearing date listed on the first page of this summons. To request and schedule email livehearings@oath.nyc.gov
- Call 1-844-628-4692 if you have a disability and require a reasonable accommodation for the hearing.
- To help avoid missing your hearing you can receive text message reminders about your case. To opt-in text "OATHreminder" to (917) 451-8829.

Option 2: ADMIT to the charge(s)

You may get an Offer of Settlement with information on how to settle and/or cure the charges(s). If you settle or cure all curable charges, you may no longer need to attend your hearing. If you settle or cure, you are admitting to the charge(s) and may face higher penalties for future charges.

Settle: Admit to the charge(s) and pay a penalty

- If you receive an Offer of Settlement, follow the instructions. The Offer of Settlement will tell you how much you need to pay.
- If you do not receive an Offer of Settlement, you may still be able to settle. Send an email or text to <u>LegalSettlements@dcwp.nyc.gov</u> and include your Summons Number. If settlement is an option, DCWP will email or text an Offer of Settlement to you. Settlement is only available before your hearing.

Cure: Admit to the charge(s) without paying a penalty (only for certain first-time charges)

Not all charges are curable. If you receive a charge that is curable, you may be able to correct it without paying a penalty. Follow the steps below.

- If you receive an Offer of Settlement it will include information about which charge(s) you can cure. Follow the instructions about how to admit the charge(s) and submit a certification. You must submit the Cure Certification within 30 days of the date the summons is issued and before your hearing.
- If you do not receive an Offer of Settlement, you may still be able to cure. **Send an email or text** to <u>LegalSettlements@dcwp.nyc.gov</u> and include your Summons Number. If cure is an option, DCWP will email or text an Offer of Settlement to you.
- Go to nyc.gov/dcwp and type "cure" in the Search tool for more information about curing a DCWP charge. Cure is only available before your hearing.



GET HELP: If you do not have a lawyer or a representative, you can schedule a free consultation with the OATH Help Center before your hearing date. Go to nyc.gov/oath/helpcenter

Penalties

You have the right to be informed of the maximum penalty. If no maximum penalty is shown on the first page of this summons, see DCWP's penalty schedules in the Rules of the City of New York, Title 6, Chapter 6, Subchapter B, beginning at Section 6-10, available at nyc.gov/DCWPPenalties. See below for additional information. Higher penalties may be imposed for each repeated violation up to the maximum penalty allowed by law or rule.

• Except for unlicensed activity, maximum penalties for the violation(s) in this summons may include a fine of as much as \$15,000 for each violation; revocation or suspension of your DCWP license; the sealing of your business premises; and/or the removal of your property. Copies of the laws and rules, which include the maximum penalties for specific violations, are available on the DCWP website: nyc.gov/DCWPPenalties.

Sale of Toy or Imitation Firearms Penalties: If you are found to have offered to sell or sold a toy or imitation firearm on three (3) or more occasions within a two-year period, the premises where the violations occurred may be sealed for up to five (5) days. See NYC Admin Code Section 10-131(g) (1) for more details.
