Removing Users

Only content that violates the New York City Social Media policy should be removed from the page.

Commands may utilize the “hide” feature rather than the “delete” feature to remove content from the page.

In a case that an account operator would like to remove content that does not violate any of the above, they should confer with DCSC staff.

Banning users is prohibited; specific cases should be brought to the attention of DCSC and DC Legal Bureau.

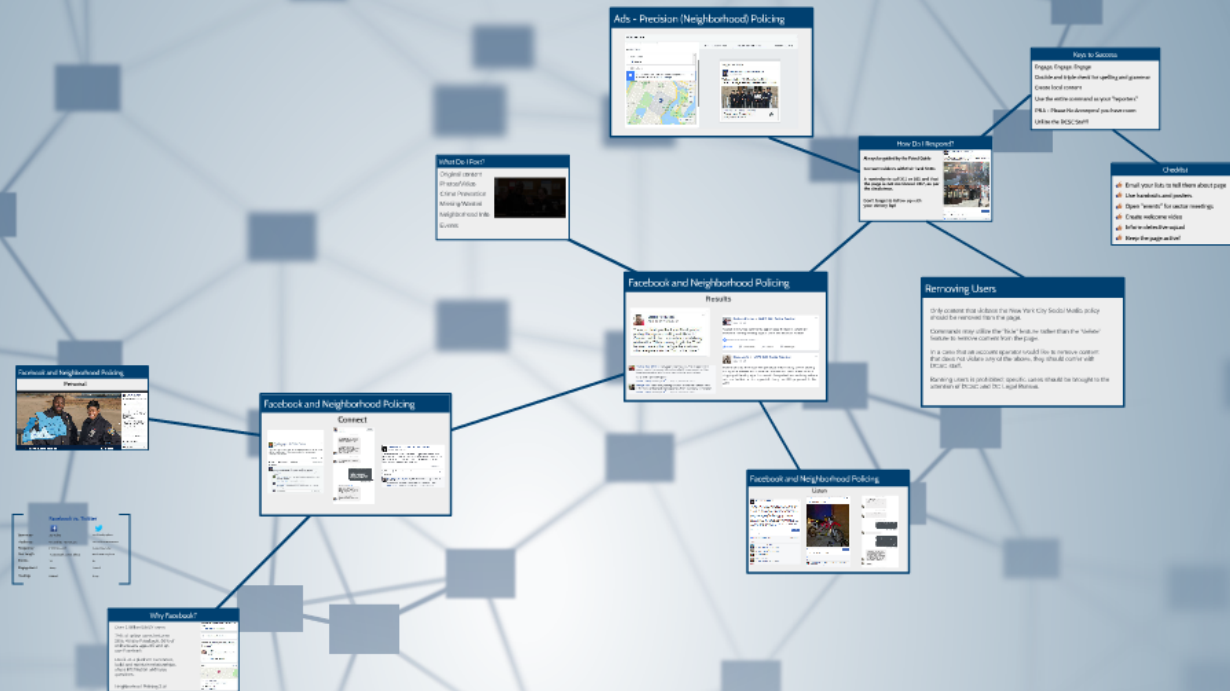
