This letter is a response to your request pursuant to the Freedom of Information Law received on May 15, 2017, for the following records:

"The text of the 2017 legal ruling, resolving a 2009 lawsuit, that resulted in members of the Council of School Supervisors and Administrators receiving parking permits from the NYC Department of Education, as referenced in the below linked memo from the NYC mayor's office and the NYC Department of Education chancellor:

In addition, I request copies of any and all correspondence, including without limitation all email correspondence sent to or from any email address within the nyc.gov email domain, referencing or pertaining to the issuance of city parking permits to members of the Council of School Supervisors and Administrators, the United Federation of Teachers, and District Council 37 in 2017, as referenced in the above linked memo."

On November 20, 2017, you narrowed your request to "any and all correspondence, including without limitation all email correspondence sent to or from certain email addresses within the nyc.gov email domain, specified below, that reference or pertain to the issuance of city parking permits to members of the Council of School Supervisors and Administrators, the United Federation of Teachers, and District Council 37 in 2017, as referenced in the following memo: https://medium.com/@NYCMayorsOffice/the-facts-on-parking-for-school-staff-ae293607aed5 Our request for relevant email correspondence is limited to all nyc.gov addresses assigned to the following: Bill de Blasio, Emma Wolfe, Richard Buery, Carmen Farina, Robert Linn, and the NYC Office of Labor Relations."

As to the portion of your request pertaining to records for Carmen Farina, Robert Linn and the NYC Office of Labor relations, please note that the Mayor's Office does not maintain those records. To seek records maintained by another agency, you must submit a FOIL request with that agency. If you wish, you may file a FOIL request with the Department of Education and Office of Labor Relations through the Open Records portal: https://a860-openrecords.nyc.gov.

After conducting a search, the Mayor's Office has identified records responsive to your request under FOIL. The responsive records are attached. Please note that some responsive materials have been redacted in part or withheld in entirety as exempt from disclosure pursuant to Public Officers Law §87(2) (b) and (g). Your request is now considered complete.
